Many payment system providers require you to enter a secure username and password to make deposits or withdrawals, on top of your existing username and password for your gaming website account. This added layer of security can help to protect you.

Without having access to that second username and password in order to make financial transactions, anyone who has gained unauthorized access to your gaming account will be limited in how much damage they can do.

Finally, most payment system providers keep accurate electronic transaction records, and can provide you with detailed online statements that you can access anytime. This will allow both you and the payment system provider to quickly spot unusual or unauthorized activity in your account, and take necessary action to protect your money.

As the industry grows, new problems and hurdles will surely surface. As quickly as such problems arise, payment system providers are working to offer you solutions.

Many of these providers are even anticipating the problems of tomorrow. An example of this forward thinking is Ezybonds' capacity to allow you to transfer funds using emails and SMS text messages on your mobile telephone.
