

Underage Players – Keeping them out and Keeping your Reputation

BBC news recently reported a study conducted by NCH¹, GamCare² and CitizenCard³ where a sixteen year old girl was able to successfully register play-for-real accounts on many gambling websites by using her Solo⁴ card and falsifying her age during the online registration process. The study covered gambling websites based both in the UK and in offshore jurisdictions such as Alderney and Gibraltar. Not surprisingly, the study caused a great embarrassment to many well-known UK names.

This is not necessarily a bad situation. It should be recognized that these types of studies are very important for the gambling industry, and they should be treated as welcome and positive. Any form of problem gambling is bad for business, as it draws negative attention to the industry as a whole, and studies such as this give us the means to identify and act upon problem gambling.

Some would suggest that the issue stemming from this study is that underage players can obtain credit or debit cards. On the contrary, the more relevant concern is that many gambling websites are not employing identity verification systems to check the age of these cardholders, thus allowing underage players to register play-for-real accounts.

Identity verification systems can come in many forms. The most common solution among socially responsible gambling website operators is to make use of readily available third-party systems, such as Experian⁵ and VerifyME⁶. These systems work by searching available governmental and financial database records to find evidence that the personal information submitted by the player during the account registration process corresponds to correct known values. For example, evidence such as a credit rating or inclusion in an electoral role will prove that the player is of the required age.

It is true that identity verification systems are not 100% effective. No individual system can ever be perfect, but there are ways to improve the effectiveness of the overall process. Many operators have chosen to make use of multiple identity verification systems to simultaneously search for falsified information during player account registration. One system could potentially pick up on something that the other has missed, and if both systems pick up on the same problem (which is most likely to be the case) then so much the better.

So how do we ensure that gambling website operators employ identity verification systems? The answer is regulation. A socially responsible jurisdiction should have in place regulatory standards requiring gambling to be conducted in a manner that is fair, safe, secure and auditable, and these standards should address issues such as underage gambling. A minimum age for account registration should be stipulated and strictly enforced by the regulatory body. Finally, a testing regime should be put in place to verify that operators have correctly designed and implemented their gambling websites, including their identity verification systems.

Operators in respected jurisdictions surely do not intend to grant play-for-real accounts to underage players; however, best intentions are not enough. This is why regulation is so critical for any respected jurisdiction.

To date, regulated jurisdictions such as Alderney⁷ have been highly successful in keeping out underage players. The study conducted by NCH, GamCare and CitizenCard cited only seven gambling websites that successfully rejected the underage player; four of which operate from the jurisdiction of Alderney. In fact, every online casino hosted from the jurisdiction of Alderney was cited as having rejected the underage player.

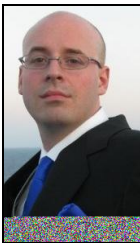
When operators implement identify verification systems to comply with regulatory age requirements, gambling websites can in many ways become more effective than land-based casinos at rejecting underage players. Unlike land-based casinos, identity verification systems cannot be fooled by players that look or act older than they really are. The online registration process ensures that each and every player is checked for their identity before they are allowed to begin wagering. In addition, gambling websites maintain detailed electronic logs of each player's wagering activity, ensuring that repudiation is possible in the event that it is required.

In summary, it is in the best interest of the operator and Jurisdiction alike to detect any underage players attempting to register with the gambling websites and deny them an account. The meagre profits that could be realized from a handful of underage players pales in comparison to the risk of bad publicity and the potential to jeopardize the operator's gaming license, not to mention the reputation of the industry as a whole.
